Overview of the Presentation

The Independent Market Operator Board has recently approved the most significant changes to the wholesale electricity market since its introduction. They will introduce competition in the provision of balancing and load following ancillary services in the Wholesale Market.

These changes came as a consequence of work done by industry representatives on the Market Advisory Committee in 2009 and the Verve Energy Review. An industry working group chaired by the Independent Market Operator (IMO) has recommended a new balancing market trial from December this year with full operation from April 2012.

Allan Dawson will give an overview of the changes and their likely impacts. Allan is the Chief Executive Officer of the IMO, the operator of Western Australia's Wholesale Electricity Market. The IMO is principally responsible for operating the electricity market, managing market evolution and securing sufficient reserve capacity to meet expected demand.

Prior to joining the IMO, Allan played a leading role in the implementation and operation of the New Zealand and Singapore electricity markets. He was CEO of the Energy Market Company in Singapore where he managed the establishment and operation of the National Electricity Market. In 2009, Allan was appointed to the Board of the Association of Power Exchanges (APEX). With over 50 market operators as members, APEX facilitates the development and communication of ideas and practices in the operation of global competitive electricity markets.
